IST, involving a deceptive Telegram channel operating under the name "**ABD Sales Volume No 1,**" and **web link** <https://www.champion-abd.com/index/user/login.html> which are falsely using the Company's brand logo. This channel is misleading individuals by promoting investments in the Company's shares and providing false information, claiming to represent the Company.

We would like to clarify that this Telegram channel and web link are unauthorized and have no affiliation with the Company.
